**NOTIFICATION**

In exercise of the powers conferred by the Sections 85 and 86, read with the Section 38 of the Bengal Excise Act, 1909 (Ben Act V of 1909), the Governor is pleased to make with immediate effect, the following amendments in the West Bengal Excise (Payment of fees for grant of license for retail sale of certain intoxicants) Rules, 2005, published under Notification no. 132EX dated 25.01.2006, as subsequently amended (hereinafter referred to as the said Rules)

:-

**Amendments**

In the said rules,-

1. In the table of Rule 4—under the heading “Category of License”—Substitute 4 (b) by “4(b) Foreign Liquor for consumption ‘off’ the site from the opium depots/erstwhile opium depots/erstwhile ganja shops”
2. In the table of Rule 4—under the heading “Category of License”—Substitute 4 (m) by “4 (m) foreign liquor for consumption ‘off’ and/or ‘on’ the premises of any canteen for Service Personnel or a canteen established by or for the Border Security Force or by or for similar other Forces, under Central Government, engaged in protection of the border of the Country”

3. In the table of Rule 4—under the heading “Category of License”-Substitute 4(n) by “4(n)-50° UP Foreign Liquor for consumption ‘Off’ and/or ‘On’ the site as supplementary license only”
4. Substitute the Table B under rule 4 by the followings—

In addition to the abovementioned fees, the applicant(s) shall pay security deposit of an amount equivalent to 1/3 of the initial grant fee, before grant of such license.
