NOTIFICATION

In exercise of powers conferred under Section 7 of the Bengal Excise Act, 1909 (Ben. Act. V of 1909) the Governor is pleased hereby to make with immediate effect the following amendments to the West Bengal Excise (Reorganisation of Excise Administration) Rules, 2012 published vide departmental Notification No. 1074-EX dated 01.11.2012 hereinafter referred to as the said rules:—

Amendments

In the said rules:—

1. In Rule 3,—

Insert a new sub-rule (vii) after sub-rule (vi) as follows:—

“(vii) 2 (two) new posts of System Analyst in the Pay Band PB-4A (Rs. 15,600 – 42,000/-) with Grade Pay Rs.5,400/- shall be created in the Excise Department.”

2. In Rule 4,—

In the 5th line of sub-rule (iii) after the words “rest of the area of the district of North 24-Parganas” insert a *coma* and the words “to be henceforth called North 24-Parganas (Rural)” followed by another *coma*.

3. In Rule 5,—

(i) In the 4th Column of Serial No. 3 of the Table under sub-rule (i) replace the words, figures and brackets “20 (twenty) Police Stations” with the words, figures and brackets “21 (twenty one) Police Stations” and at the end after the words “Pragati Maidan” insert a *coma* and the word “Parnashree”.

(ii) In the “N.B” to the said Table under sub-rule (i) replace the words, figures and brackets “14 (fourteen) Police Stations” with the words, figures and brackets “15 (fifteen) Police Stations” and insert the words “and Parnashree” after the word “Haridebpur” in the 2nd line.

4.

(i) In Rule 6 (I),—

In the table showing Manufacturing Units in Jalpaiguri Excise District under sub-rule 3 (iii) insert another row as under:

3	M/s PDCL Luksan C.S Bottling Plant, Luksan	1	1

(ii) In Rule 6 (II),—

In the table showing Manufacturing Units in Alipurduar Excise District under sub-rule 3 (iii) omit the row at serial number “1” and change the serial number of the second row to “1”.

5. In Rule 6 (V),—

(i) In sub-rule (1) after the words “the remaining areas of the district of North 24 Parganas” insert a *comma* and the words “to be henceforth called North 24-Parganas (Rural)”.

(ii) In sub-rule 3 (i) in the table showing Circles in North 24-Parganas District read “North 24 Parganas” as “North 24 Parganas (Rural)”.

(iii) In sub-rule 3 (ii) in the table showing Ranges in North 24 Parganas District read “North 24 Parganas” as “North 24 Parganas (Rural)”.

6.

(i) In Rule 6 (VIII),—

Insert a new sub-rule 3 (iii) after sub-rule 3 (ii) as follows:—

“iii) Manufacturing Unit(s) in Bardhaman (East) Excise District:

1	M/s IFB Agro Industries Ltd., C.S Bottling Plant, P.O-Panagarh, P.S-Budbud	1	1

(ii) In Rule 6 (IX),—

In the table showing Manufacturing Units in Bardhaman (West) Excise District under sub-rule 3 (iii) omit the row at serial number “1” and re-number serial numbers “2 to 6” as “1 to 5”.

7. In Rule 6 (X),—

(i) In the table showing Circles in Purulia District under sub-rule 3 (i) Kenda P.S shall be removed from the ordinary jurisdiction of Kashipur Circle and included within the ordinary jurisdiction of Hura Circle.

(ii) In the table showing Ranges in Purulia District under sub-rule 3 (ii) Neturia Circle shall be removed from the ordinary jurisdiction of Balarampur Range and included within the ordinary jurisdiction of Raghunathpur Range.

8. In Rule 6 (XV),—

In the table showing Circles in Malda District under sub-rule 3 (i) Ratua P.S shall be removed from the ordinary jurisdiction of English Bazar Circle and included within the ordinary jurisdiction of Manikchak Circle; and Kaliachak P.S shall be removed from the ordinary jurisdiction of Manikchak Circle and included within the ordinary jurisdiction of English Bazar Circle.

9. In Rule 6 (XVI),—

In the table showing Ranges in South 24 Parganas District under sub-rule 3 (ii) Bhangore Circle shall be removed from the ordinary jurisdiction of Baruipur (Sadar) Range and included within the ordinary jurisdiction of Canning Range.

10. Insert an “*Explanation*” after Rule 6 (XXIV) and before Rule 6 (XXV) as follows:—

Explanation:— In case of creation of new police stations by way of delimitation of existing ones, such police stations shall be included within the ordinary jurisdiction of the Excise Circles within which the mother police stations, from which the new police stations were primarily carved out, existed before such delimitation.
